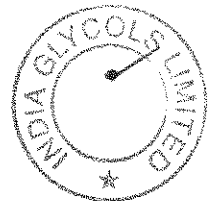

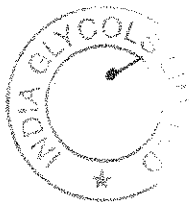

 Further, in pursuance to the above order of Hon'ble NCLT, Kolkata, Supreet Vyapaar Private Limited ("Supreet"), a Promoter Group Company was amalgamated with KHL, the Promoter Company. Accordingly, 2,67,895 equity shares held by Supreet were transferred to KHL on 2nd December, 2024.
