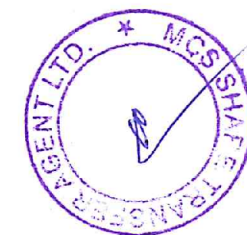

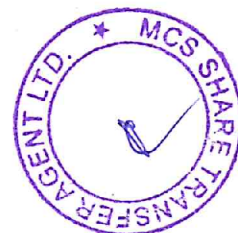

*Pursuant to the Composite Scheme of Arrangement as approved by NCLT, Kolkata and which became effective on 2nd December, 2024, 35,11,924 equity shares were acquired by Kashipur Holdings Limited ("KHL") (Promoter Company) from Ajay Commercial Company Private Limited (6,11,255 equity shares), Facit Commosales Private Limited (10,57,853 equity shares), JB Commercial Company Private Limited (9,77,915 equity shares), J. Boseck & Co. Private Limited (8,64,401 equity shares) and Lund & Blockley Private Limited (500 equity shares). Further, in pursuance to the above order of Hon'ble NCLT, Kolkata, Supreet Vyapaar Private Limited ("Supreet"), a Promotor Group Company was amalgamated with KHL, the Promoter Company. Accordingly, 2,67,895 equity shares held by Supreet were transferred to KHL on 2nd December, 2024.

(6) Pursuant to the approval of the Board of Directors at its meeting held on 30th May, 2025 and subsequently by the shareholders of the Company on 22nd July, 2025, the Company has undertaken a sub-division/split of its equity shares, whereby 1 (One) equity share of face value ₹10/- (Rupees Ten only) each has been sub-division/ split into 2 (Two) equity shares of face value ₹ 5/- (Rupees Five only) each, with effect from 12th August, 2025 and in this regard the Company has executed the Corporate Action on 13th and 14th August, 2025. Accordingly the number of equity shares has been increased from 3,09,61,500 equity shares having a face value of Rs. 10/- each to 6,19,23,000 equity shares having a face value of Rs. 5/- each.

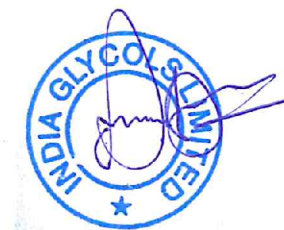
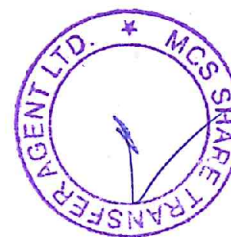

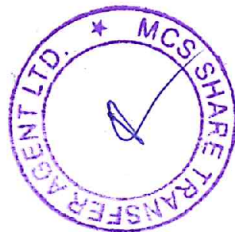
