(5) Pursuant to the provisions of regulation 31(4) M/s Kashipur Holding Limited is the promoter of the Company whereas all other individuals/Body corporates are falling under the Category of Promoter Group.

*Pursuant to the Composite Scheme of Arrangement as approved by NCLT, Kolkata and which became effective on 2nd December, 2024, 35,11,924 equity shares were acquired by Kashipur Holdings Limited ("KHL") (Promoter Company) from Ajay Commercial Company Private Limited (6,11,255 equity shares), Facit Commosales Private Limited (10,57,853 equity shares), JB Commercial Company Private Limited (9,77,915 equity shares), J. Boseck & Co. Private Limited (8,64,401 equity shares) and Lund & Blockley Private Limited (500 equity shares).

Further, in pursuance to the above order of Hon'ble NCLT, Kolkata, Supreet Vyapaar Private Limited ("Supreet"), a Promotor Group Company was amalgamated with KHL, the Promoter Company. Accordingly, 2,67,895 equity shares held by Supreet were transferred to KHL on 2nd December, 2024.

(6) Pursuant to the approval of the Board of Directors at its meeting held on 30th May, 2025 and subsequently by the shareholders of the Company on 22nd July, 2025, the Company has undertaken a sub-division/split of its equity shares, whereby 1 (One) equity share of face value ₹10/- (Rupees Ten only) each has been sub-division/ split into 2 (Two) equity shares of face value ₹ 5/- (Rupees Five only) each, with effect from 12th August, 2025 and in this regard the Company has executed the Corporate Action on 13th and 14th August, 2025. Accordingly the number of equity shares has been increased from 3,09,61,500 equity shares having a face value of Rs. 10/- each to 6,19,23,000 equity shares having a face value of Rs. 5/- each.

(7) Pursuant to the approval of the Board of Directors accorded at their meeting held on 16th October, 2025 and subsequently by the Shareholders of the Company on 12th November, 2025, the Company had allotted 51,03,765 equity shares on preferential basis having a face value of Rs. 5/- each on 24th November 24, 2025 to both "Promoter" and "Non-Promoter" categories. Out of which, 21,85,790 Equity Shares were allotted to the Promoter category and 29,17,975 equity shares were allotted under the Non-Promoter category. The entire 51,03,765 equity shares were credited to the Temporary ISIN: IN8560A01022 in pursuance to applicable provisions as on 31st December, 2025. However, the Listing & Trading approval for these shares were received from NSE and BSE on 5th January, 2026 effective 6th January, 2026.

Accordingly, for the Shareholding pattern for the quarter ended on 31st December, 2025, we have clubbed the shares in main ISIN i.e. INE560A01023 and Temporary ISIN i.e. IN8560A01022 to reflect the actual paid-up share capital and shares under lock-in as on 31st December, 2025 for the relevant fields of the promoter and Non-Promoter category (public shareholding).

(8) As the equity shares allotted to the promoters pursuant to the preferential issue were not admitted for listing and trading as of 31st December, 2025 and kept under a separate ISIN, which has been clubbed for the purpose of this shareholding pattern, the promoter shareholding is appearing less than 100% in dematerialised form. However, the entire allotment under the preferential issue was made in dematerialised form in compliance with Regulation 170(4) of the SEBI ICDR Regulations, 2018. Subsequently to quarter ended 31st December, 2025, Both NSE and BSE vide their letter dated 5th January, 2026 granted Listing and Trading Approval effective 6th January, 2026 for these shares.
