Nature and details of the action(s) taken, initiated or order(s) passed	The Adjudicating Authority vide order dated 18 th December 2025 (received on 29 th December, 2025) has confirmed Customs duty demand of Rs. 32,95,005/- being duty short paid along with applicable interest and also imposed equal amount of penalty of Rs.32,95,005/- under the Customs Act, 1962.
Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority	29 th December, 2025
Details of the violation(s)/contravention(s) committed or alleged to be committed;	The matter relates to customs classification of certain goods imported by the Company's Ennature Bio-Pharma division during the period June, 2020 to September 2024.
	The Company submitted a detailed reply to the allegations raised in the Show Cause Notice ("SCN") issued by the Joint Commissioner of Customs, Air Cargo Complex (Import), Delhi. However, the adjudicating authority did not consider the submissions in the right prospective and confirmed the entire duty demand of Rs.32,95,005/- along with applicable interest and also imposed a penalty.
	The Company had already deposited the duty demand of Rs.32,96,284/- along with interest of Rs.11,22,338/- aggregating to Rs. 44,18,622/- under protest, before the issuance of SCN which has been appropriated towards the amount of short duty paid and interest thereon, by the adjudicating authority.
Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible.	Based on the Company's assessment and advice of the counsel, the Company has a strong case on merits, and the imported goods were appropriately classified by the Company under CTH which has not been properly appreciated by the adjudicating authority. Accordingly, the Company will file the appeal and does not reasonably anticipate any material impact on its financial or operational or other activities.
